#### Free Legal Resource: Separate Writing

While you are staying safer at home, you may be spring cleaning and also organizing your space and your mind. During this time, you may want to consider recording who will receive your treasured personal effects upon your passing. Florida law permits the use of a "separate writing" to dispose of certain items of personal property as part of your last will and testament. This allows you to make small changes to your estate plan without going to your attorney. Your separate writing may include personal property such as:

- art, antiques and jewelry
- silverware, china and glassware
- collections
- furniture and furnishings
- vehicles

but specifically excludes gifts of cash, stocks, and bonds. If you think your heirs may argue over your property, or if you promised a specific item to a person, you would write it down on a separate sheet, which is then legally binding. ## Dawn's Simple Spice Mix

With the Safer at Home Order, Medicaid Outreach Coordinator Dawn Gretter and her husband have been grilling at home more often. To make their dinners simpler, without sacrificing taste, they have been adding her easy spice mix to almost everything: tofu, meat, poultry, fish, veggies, pasta and more!

- 1 ½–2 tbsp paprika
- 2 tsp celery salt
- 2 tsp turmeric
- 1–2 tsp garlic powder or 2–6 cloves fresh, chopped garlic to taste
- 1 ½ tsp cumin
- 1 ½ tsp white pepper
- 1 tsp salt
- 1/2 tsp black pepper

#### Optional

 1–2 tsp cayenne pepper for an extra kick

This is the base of the flavor mix so you can also add other herbs and spices, fresh or dried, (like basil, rosemary, thyme, sage, etc.) if you like. Every week Dawn will pre-mix and put in a shaker jar or a glass bowl to keep handy.
